Detection of miscellaneous chaotic systems

The question underlying the expression retro-modelling is the following: is it possible to retrieve the original formulation of a given dynamical system from a set of observed time series generated by this system (and without any extra information)? To answer this question, the Rössler system¹ was extensively used in the previous vignettes, in particular in vignettes 3 **Modelling** and 6 **Sensitivity**, to show that the global modelling is very efficient to retrieve this system under various conditions of noise, subsampling, short length time series, etc. In the present vignette, other three-dimensional chaotic systems are considered in order to check the generality of the technique. Seventeen other systems are considered in the present vignette which equations can be loaded as follows:

These systems were used to produce time series. These time series can also be directly loaded as follows:

In the following experiments, these time series are used as an input of the GPoM package to check if the sets of original equations can be retrieved.

The Nosé-Hoover-1986 system

The Nosé-Hoover system was discovered by Shūichi Nosé² and William Hoover³ in 1986 (it was rediscovered by Sprott in 1994, known as Sprott-A). This system reads

This system is particularly interesting because, despite their deterministic couplings, the three variables are characterized by quite different signals:

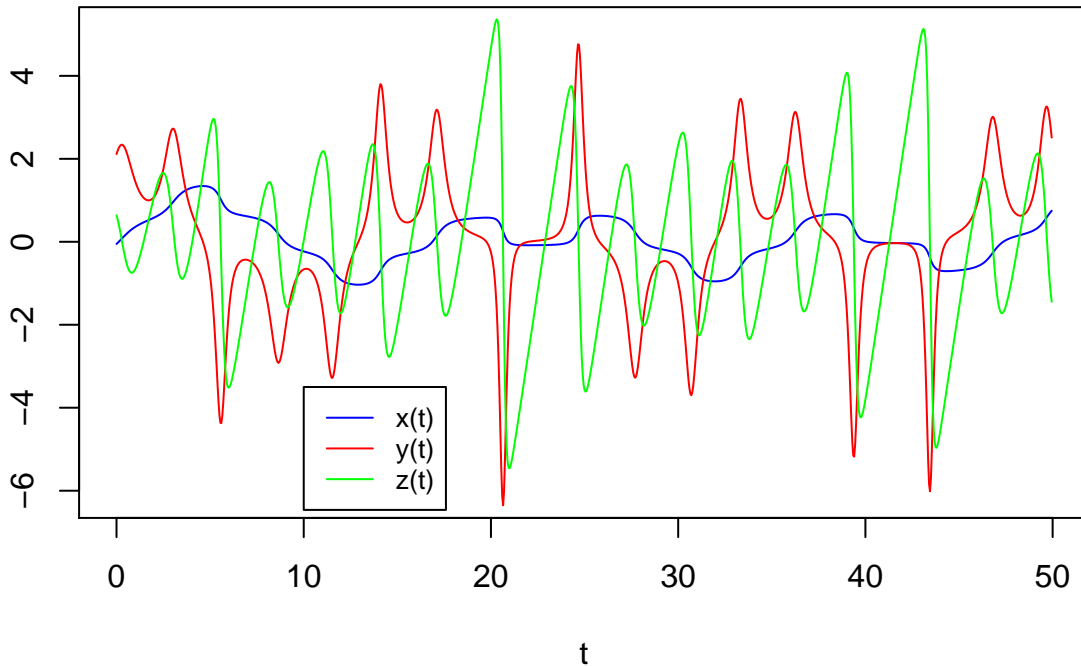

And the three variables are almost completely decorrelated.

Indeed, correlation does not exceed ~ 0.142 (the maximum correlation is observed between x and z), and it is almost zero between x and y (~ 0.025) and between y and z (~ 0.016). Obviously, for such a type of dynamic, the correlation may be particularly misleading information for whom would like to detect the existence of a causal coupling.

Global modelling

The GPoM package^{4, 5} is used to investigate the relations existing between the three time series $x(t)$, $y(t)$ and $z(t)$ shown above. A drastic model selection is performed by the `gPoMo` function when trying to obtain a global model from a set of observational time series. The numerical integration is then used to obtain an optimal model among the few models preselected by the function:

With the only exception of model #6, the preselected models are either diverging (models #1, #2, #4, #5, #7 and #10) or converging to a fixed point (#3, #8 and #9). Equations for model #6 effectively correspond to the original system:

Therefore, despite the absence of correlation observed between the three variables, the proper formulation is directly and completely retrieved. Note that allowing models of larger size (e.g. with `nPmax = 6`), three other models of nontrivial solution can be obtained (models #12, #14 and #15). The model #6 should be preferred from these for its more parsimonious formulation.

The results obtained for this system are especially interesting since providing an obvious evidence that correlation is not a good tool for the detection of linkages between dynamical variables. Contrarily, the retro-modelling technique enables not only to detect the couplings. Furthermore, it goes far beyond, by making it possible to retrieve the original and complete formulation of the coupling between the three variables.

The Genesio-Tesi system (1992)

The following differential equations was introduced by Roberto Genesio and Alberto Tesi in 1992⁶

$$d^3x/dt^3 + a.d^2x/dt^2 + b.dx/dt + x(1 + x) = 0,$$

(for $a = 0.446$ and $b = 1.1$) which can be rewritten in the canonical form:

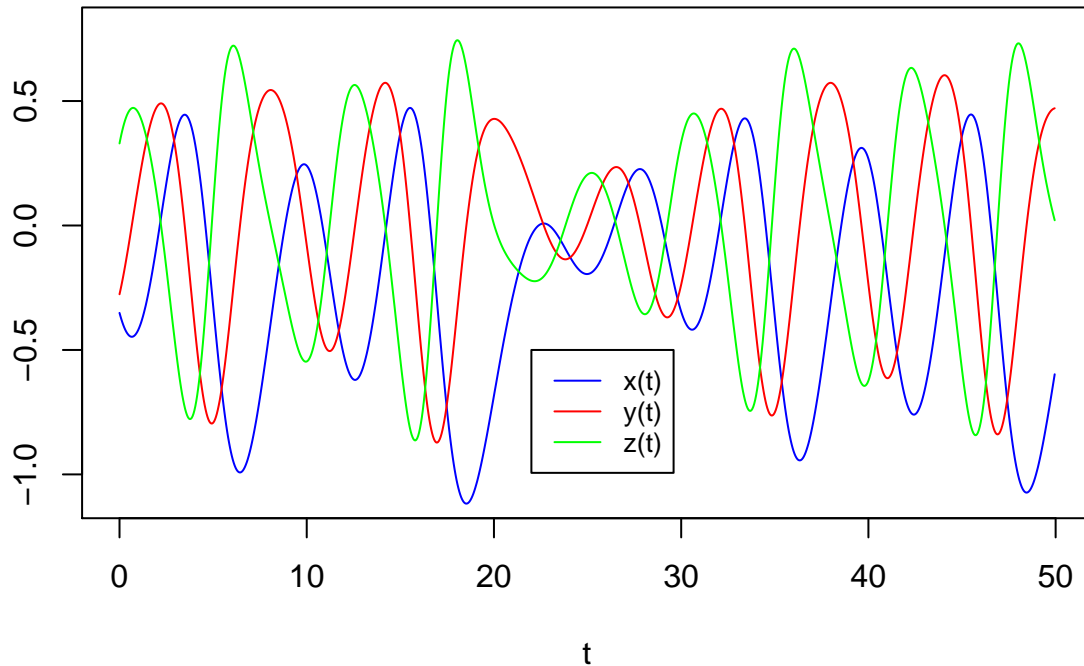

And the global modelling technique was then applied to this set of time series:

Note that obtained models of smaller size have period-1 cycles (these can be obtained by setting `nPmin = 3`). The complexity of the observed signal is thus not reproduced by these models and these can be rejected. Allowing models of larger size (`nPmax = 7`), interesting solutions will be obtained (in terms of phase portrait), but their formulation will be less concise and the previous formulation obtained with model #1 should thus be preferred.

The Sprott systems

Numerous systems were discovered (some rediscovered) by Julian Clinton Sprott in the 1990s⁷. Several of these are considered in this section, namely systems Sprott-F, H, K, O, P, G, M, Q and S.

The Spott-F system

The Sprott-F system reads:

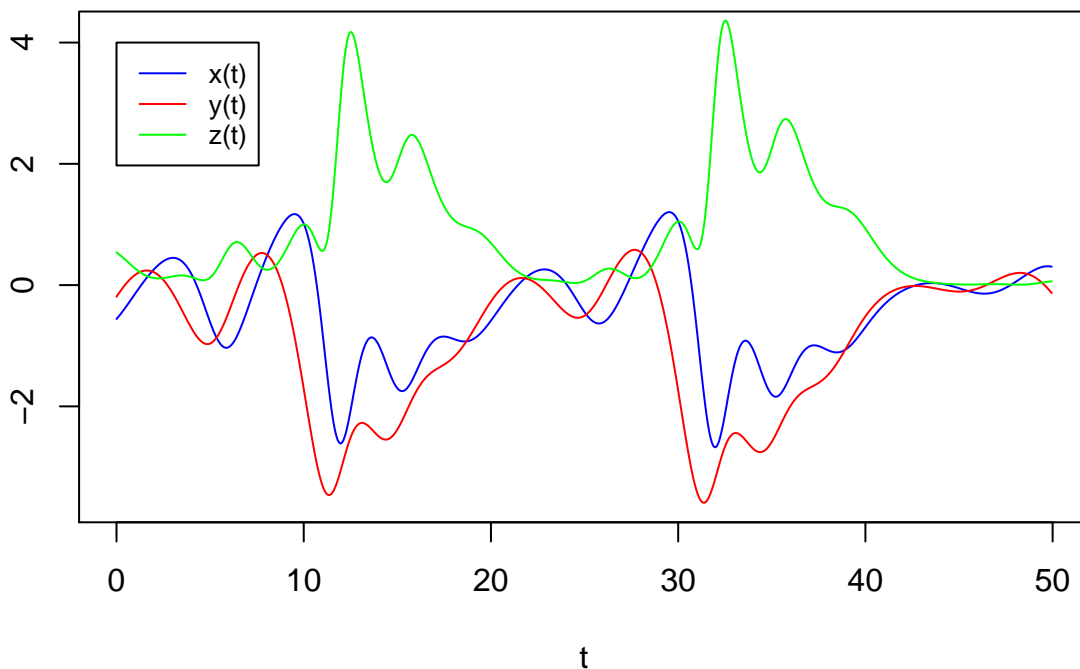

A specific attention was paid uupper to the Nosé-Hoover system for its very low correlation. The Sprott-F system is interesting for the opposite reason: its variables are characterized by a high level of correlation (or anticorrelation) as shown by the following plots $x(t)$, $y(t)$ and $z(t)$:

Correlation is high between the three variables: ~ 0.68 between $x(t)$ and $y(t)$, ~ 0.74 between $x(t)$ and $-z(t)$, and ~ 0.77 between $y(t)$ and $-z(t)$:

Note that allowing a larger range of model size ($nPmin = 3$ and $nPmax = 7$), models solutions can be rejected either because they are diverging or oversimplified (models #3-14, #16-24, #26-27 and #30-35), or because they are less parsimonious (models #15, #25, #28 and #29).

The formulation of the original system is thus effectively retrieved:

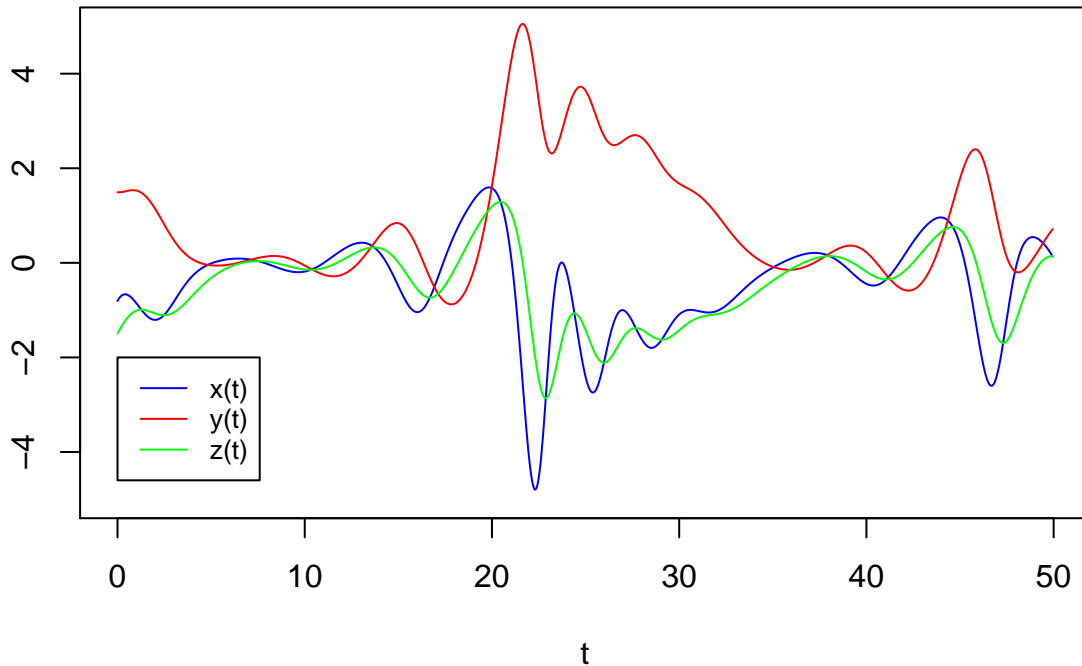

Correlation is high between $x(t)$ and $z(t)$ (~ 0.77), and $x(t)$ and $-y(t)$ (~ 0.63), and lower between $y(t)$ and $z(t)$ (~ 0.38):

Surprisingly, the simplest model able to reproduce the original phase portrait has six terms, that is, one less term than the original model: the term $-y$ is missing in the second equation. This obtained model reads

This term is not detected because it is of small influence on the dynamics (actually the dynamic of variable y is more or less similar to the dynamic of x – See upper the observed time series – and its coefficient is 28 times smaller). Three 7-parameter models were also obtained, all having a phase space very similar to the original one. The original model (#18) is included among them :

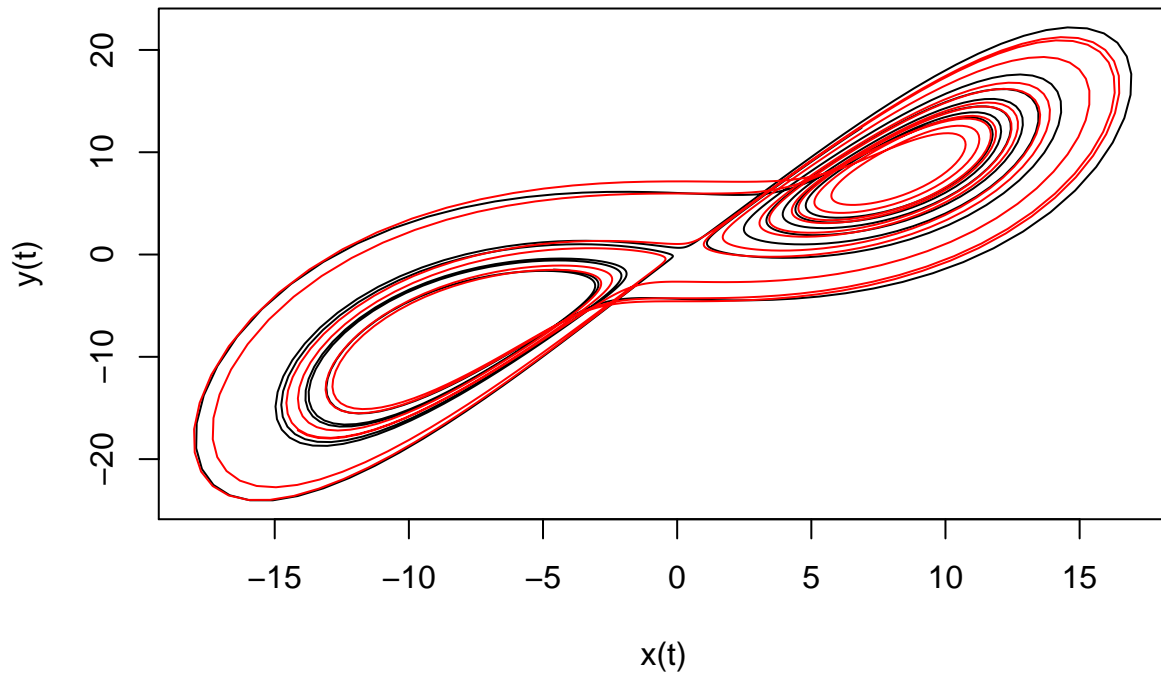

Since model #5 is more parsimonious, it can be considered that six of the seven terms of the Lorenz system are thus clearly detected. A more in-deep investigation might enable the detection of the term of weaker

influence, but this remains unsure. The phase portraits of four potentially valid models are very close to the original phase portraits, it may be quite quite challenging to retrieve the full formulation of the original equations.

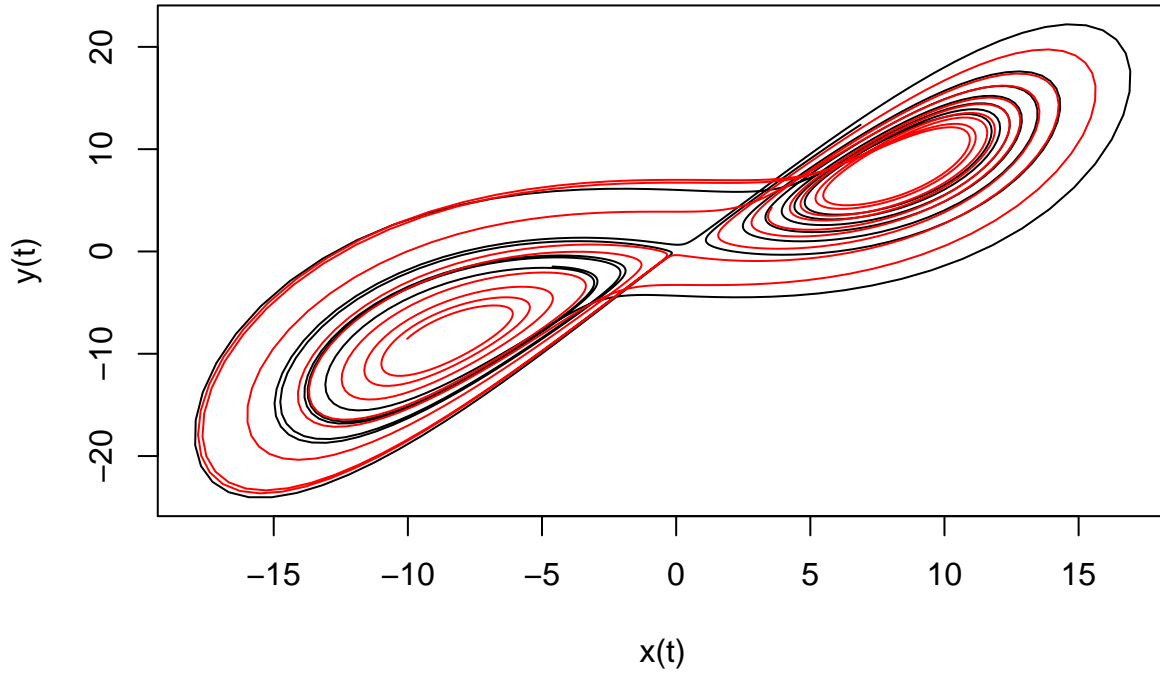

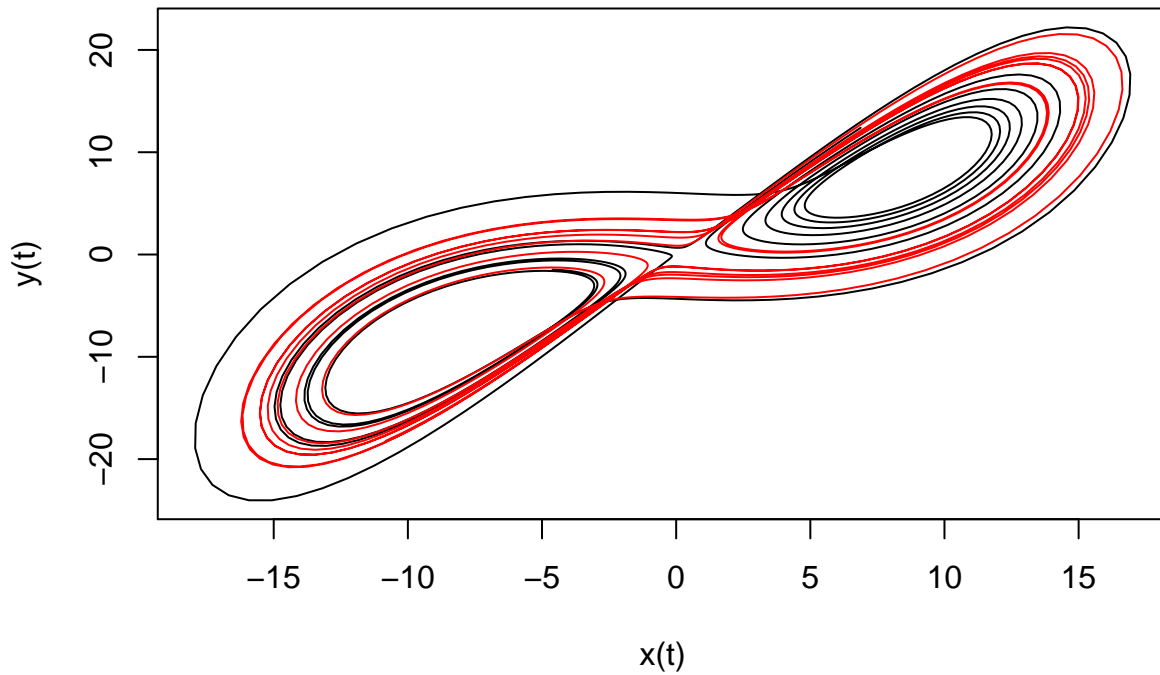

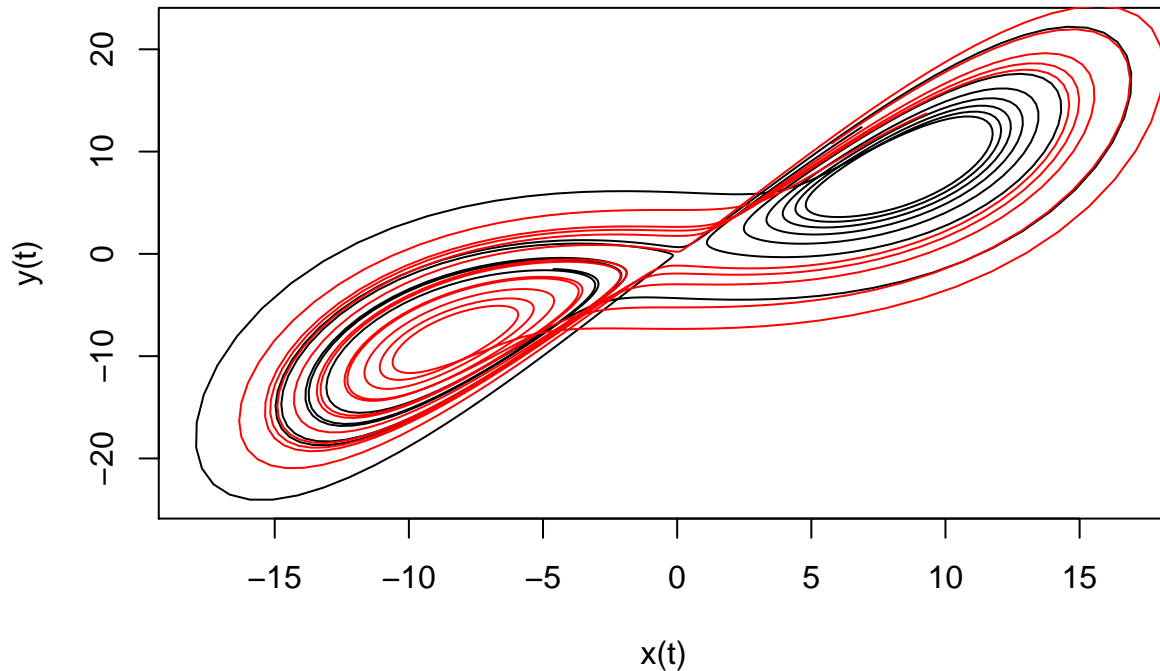

A very refined validation technique based on the transition matrices⁹ may be a powerful tool to reach such a level of precision for the distinction.

The Burke and Shaw system (1981)

The system discovered by Bill Burke and Robert Shaw¹⁰ in 1981 is a Lorenz-like system. This system reads

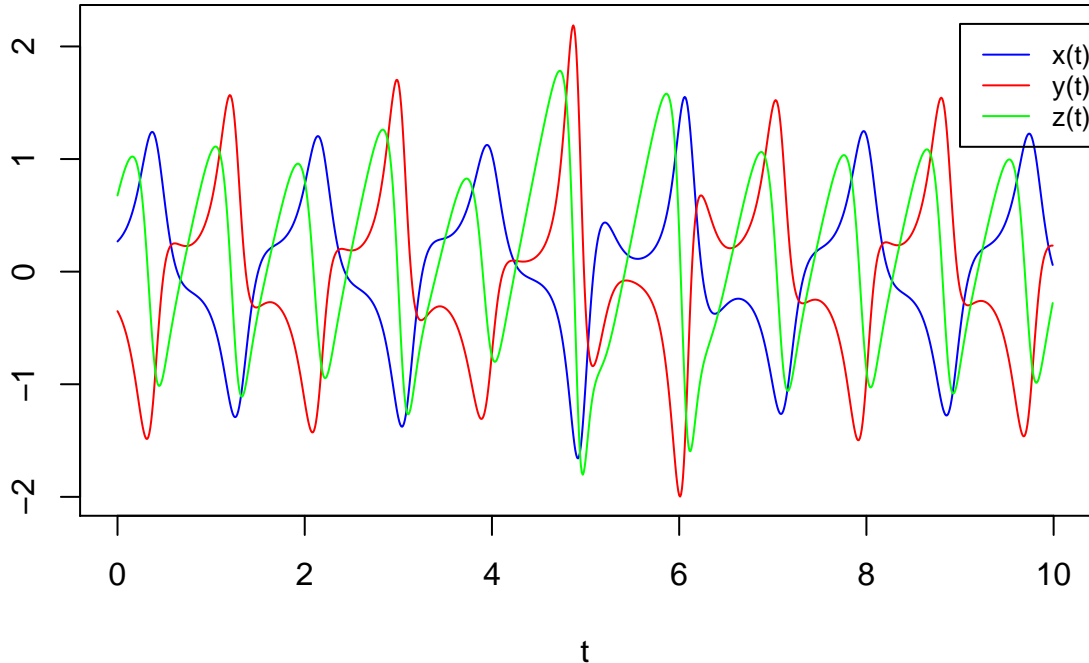

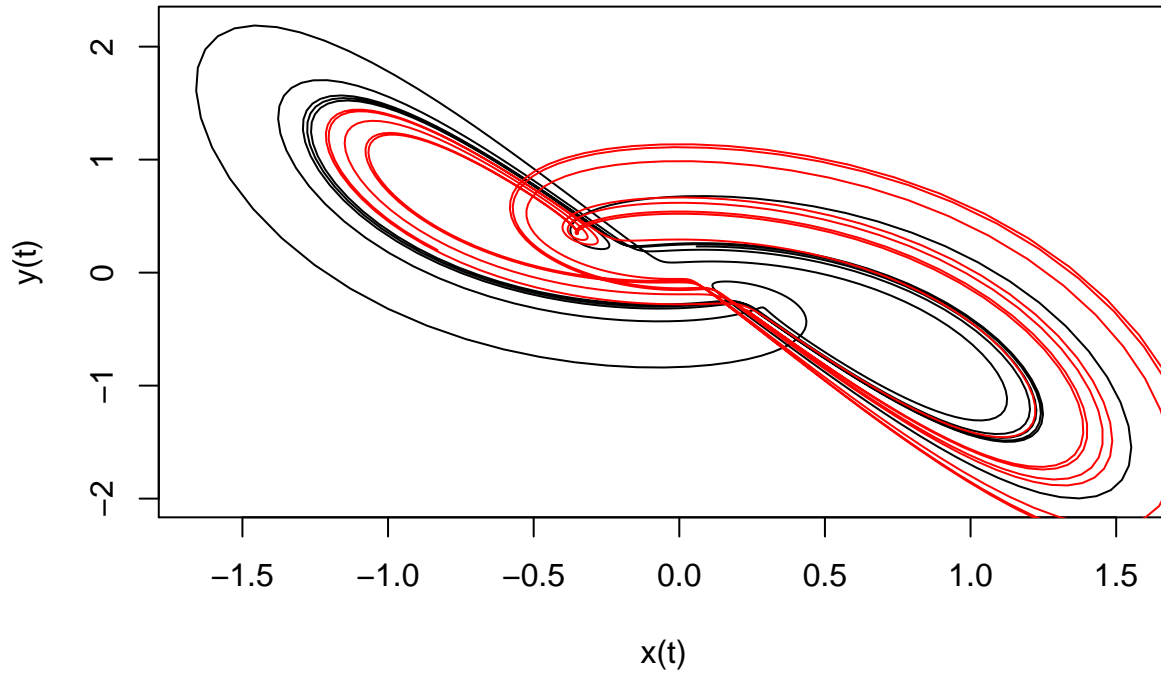

A more in-deep investigation will be required to check if the term of weaker influence can be detected. At

this stage, it can already be observed that the phase portrait of the model with the proper formulation (model #11 in red) seems closer to the original phase space (in black).

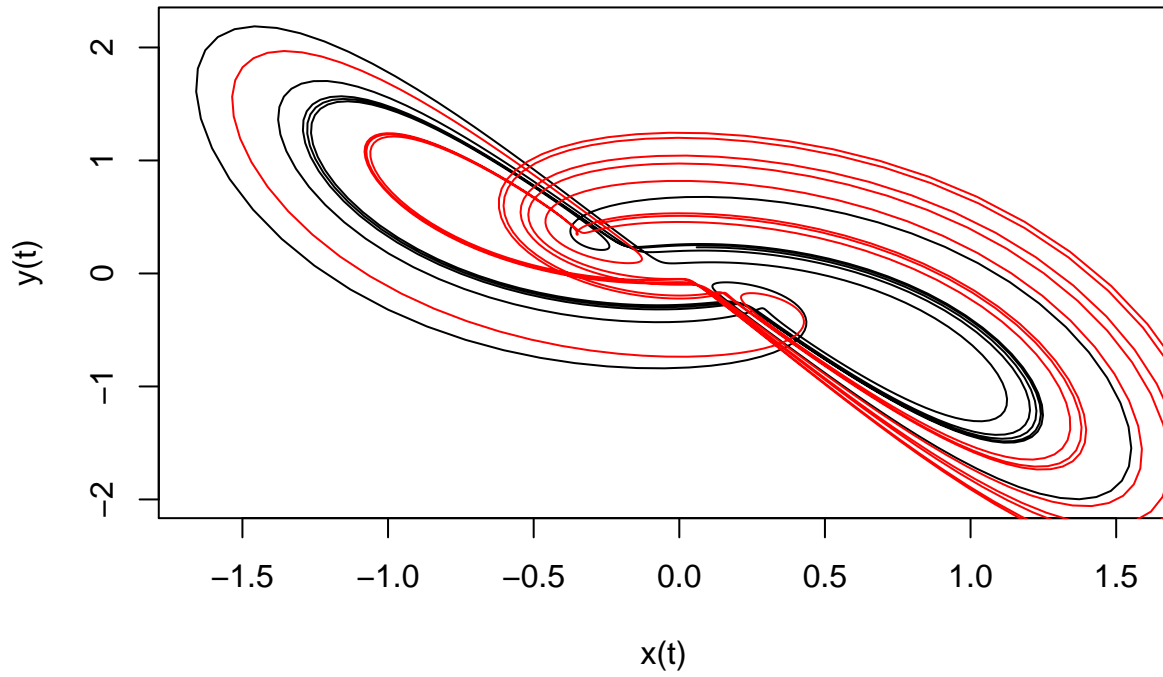

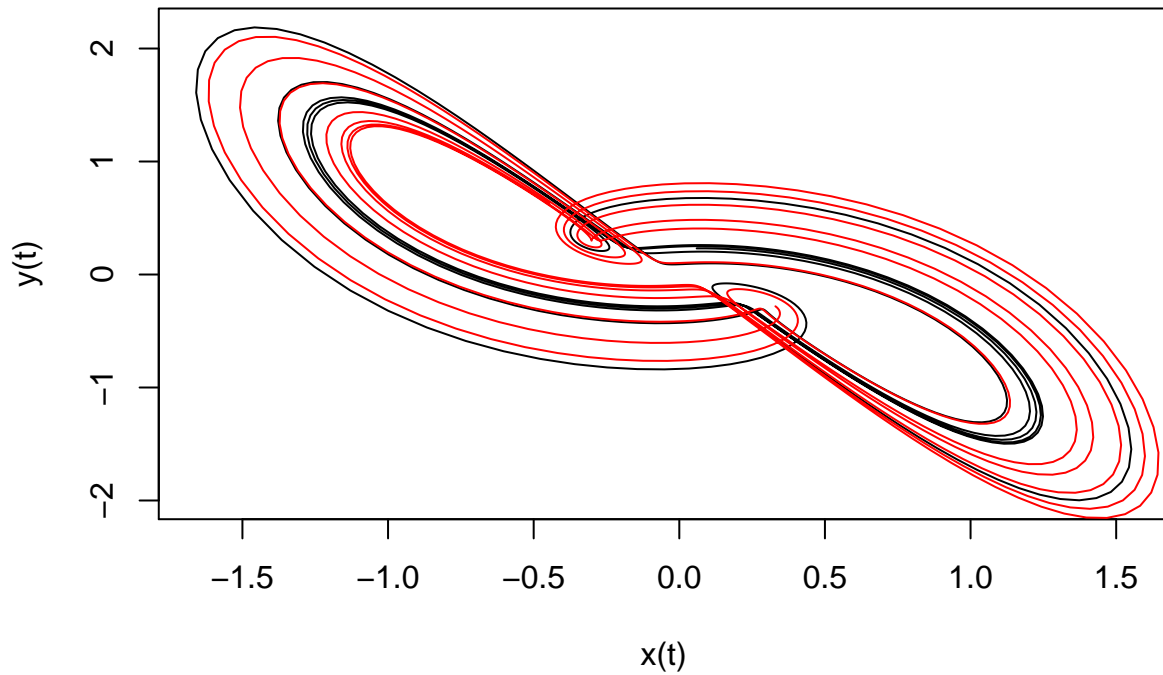

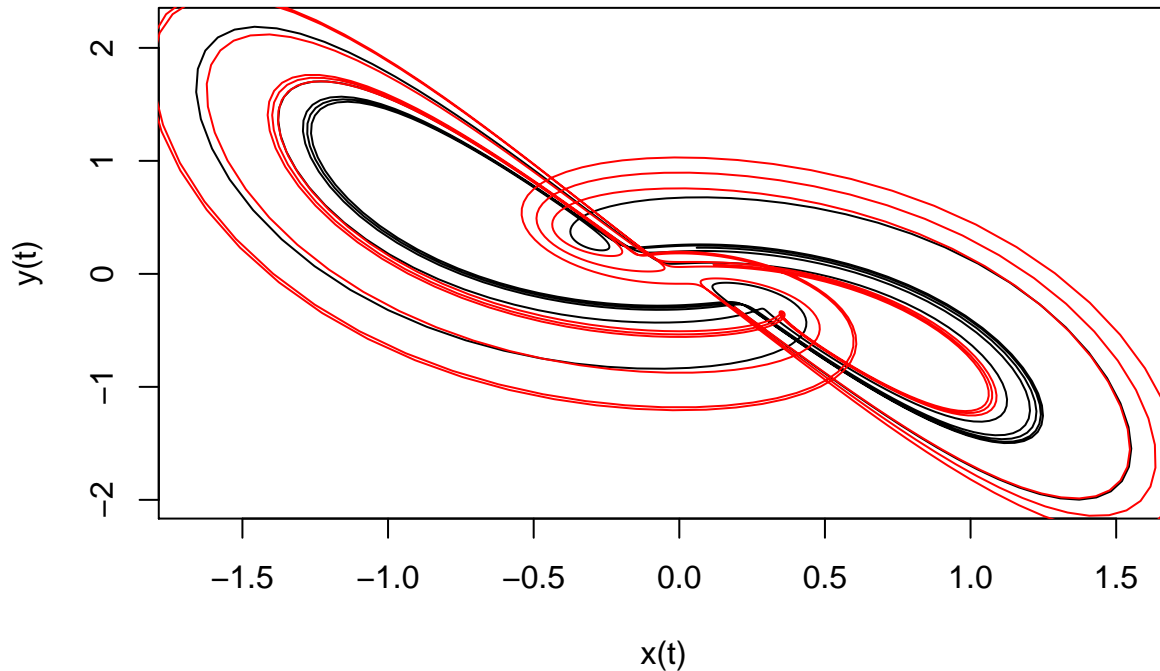

The Lorenz-1984 system

The Lorenz-1984 system¹¹ was discovered by E.N. Lorenz in 1984. This system is much more complex than the systems previously considered.

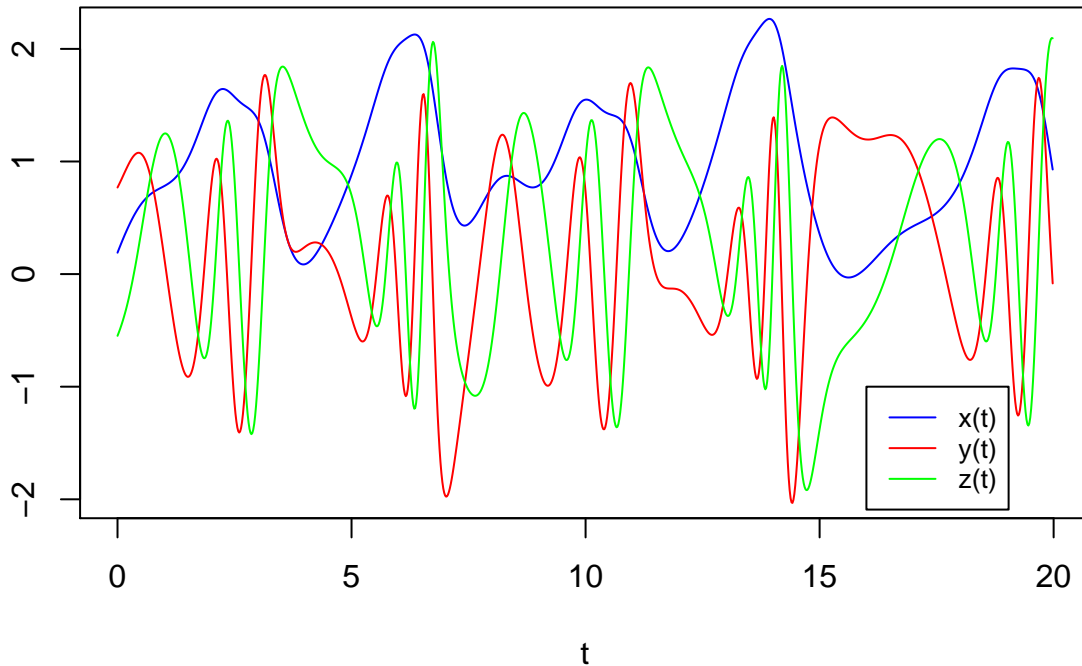

However, its attractor is periodic and symmetric. Therefore, it is obviously not a precise approximation of the observed time series. The first model showing a high level of complexity is the model #9. This model has 6 terms

Although several terms are missing (two in the first equation, three in the second one), it can be noticed that the detected terms are effectively present in the original system.

Many other models were obtained (models with 7 terms: #19 and #22; with 8 terms: #34, #40 and #49; with 9 terms: #55, #64, #76 and #77; with 10 terms: #83, #92-94, #97-99, #111 and #113; or with 11

terms: #119, #128, #129, #133, #134, #136, #139, #140-142, #147-149 and #155-158). Most of these models have strongly negative values along the x abscissa and can thus be rejected. Only a few of them may be considered as potentially acceptable (models #9, #55, #77, #113, #119, #141 and #158). A visual inspection of the phase portraits obviously shows that the best agreement is obtained with the model #141.

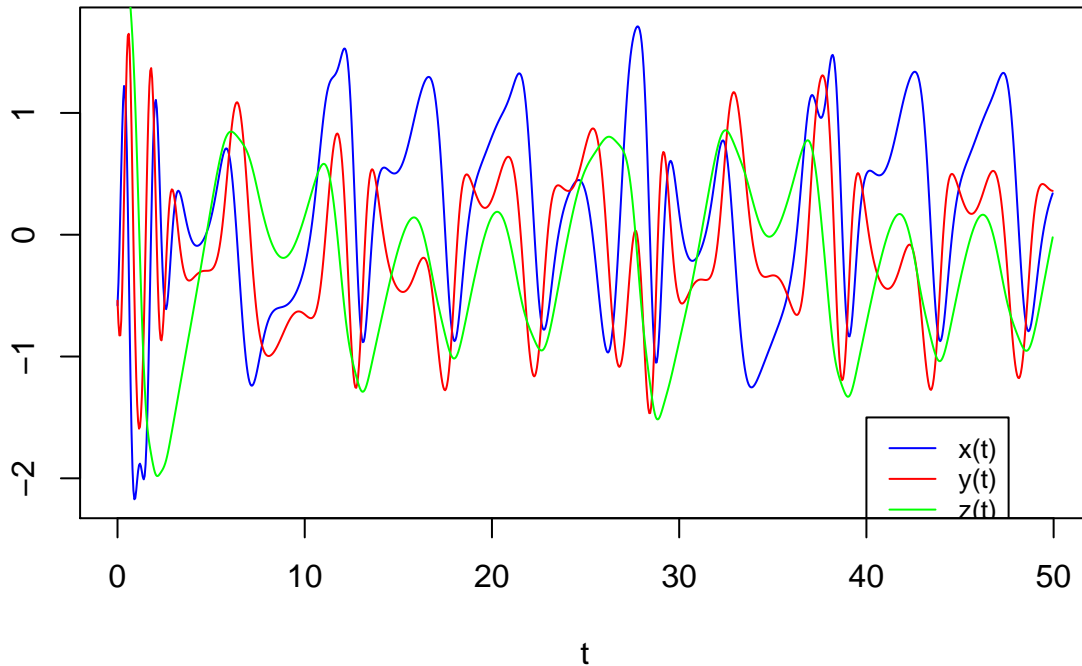

Three types of models were obtained (type-1: #7, #13, #15, #23, #25, #38, #40, #43; type-2: #12, #22, #27, #37; and type-3: #26, #30, #41, #44-46, #49) among which only type-3 models seem compatible with the original phase portrait (the other types can only reproduce a small part of the original phase space). Some spurious effects being observed in models #30 and #49, only five models may be potential candidates: models #26, #41 and #44-46. The smallest model (#26) obtained with the third type has the following formulation

It is almost identical to the original system since only one term is missing in the second equation.

The complete formulation is obtained in model #41. However, it is difficult to tell which model is the best when comparing models #26, #41, #44 and #45. These results suggest that the original system may be reducible to a 7-term system.

The Li system (2007)

A toroidal and symmetrical system was introduced by Dequan Li in 2007¹³:

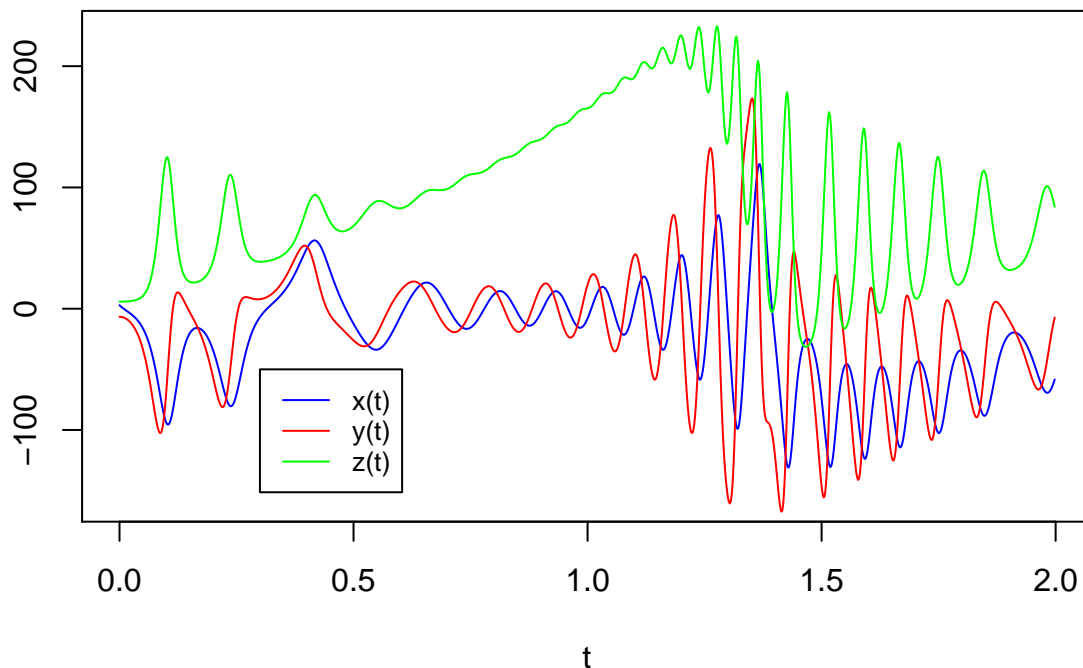

The cord attractor¹⁴ was introduced by Luis Aguirre and Christophe Letellier in 2012 by a modification of the Lorenz-1984 system. The system reads:

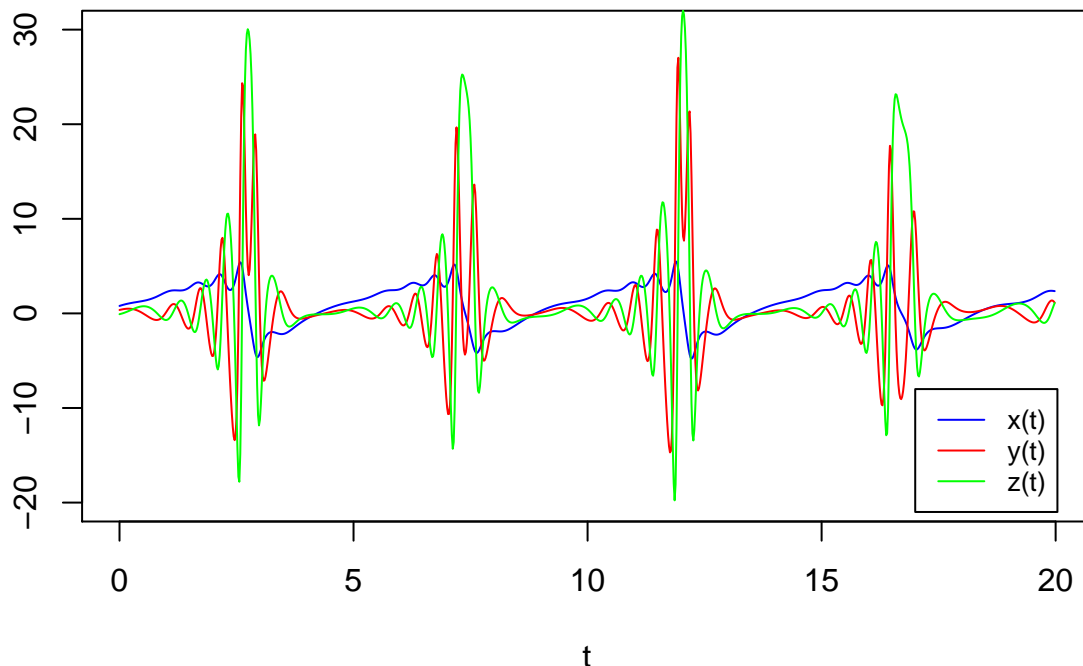

Several obtained models were able to reproduce, more or less, the original phase space are obtained. The smallest models (#9 and #10) have seven terms and are not chaotic. Their formulation is similar to the original system. All the terms detected in model #9 are effectively included in the original system (four terms are not detected).

Only one spurious term (lower in magnitude compared to the others) is detected in model #10 (term z^2 in the first equations) and five terms are not detected:

Among all the obtained models, the phase portrait of model #62 is the more similar to the original one.

In this formulation, eight of the eleven terms are correctly detected. The same spurious term is wrongly detected (term z^2 in the first equations).

The cord system cannot be retrieved completely in the present case, possibly because its formulation is too complex (too many terms) and not minimal. The most important terms can be detected.

Conclusion

In this vignette, it is shown that, in many cases, the original systems can be fully retrieved. It is in particular the case when the formulation of the original system is concise enough. But it is not always the case. When the systems formulation is more complex (more terms), an exhaustive detection becomes more difficult and only one part of the algebraic terms can be detected. In such conditions the global modelling technique can be used to obtain a reduced formulation of the dynamical systems.
